

Suggested areas of statements to be sworn to and asked of ELIAS CHAJET whose address is 802 - Canal Street, Miami Beach, Florida by Edward N. Cloughton and William M. Howell as suggested by the Assistant Minority Counsel of the U. S. Senate Select Committee on Presidential Campaign Activities.

Full name, address, date and place of birth, nationality of parents, basic background and history, places of residence, family politics, current health, name of doctor and any medication now being taken, political history (both in and out of U. S.) and that he supported President Nixon in the last campaign, voters registration, funding, duration, funding and operations of C.H.I.P.P.

Problems, duration and basis of knowledge and association with Sturgis.

Background of Kaiser and Sturgis as regards to C.H.I.P.P.

Statement as to Chajet's political and humanitarian interests versus military actions and if physical limitations are involved.

Relationship between Sturgis and Chajet meetings. Confidences, friendship, daily companionship, close trust, projects discussed, money intercepted, when Sturgis began talking about Big Project, what Chajet thought Big Project was from conversations, what any other persons may have thought that knew about it? Who was involved? Who was the Boss? Was it a CIA Operation?

Haiphong Mining Activities with Sturgis, Caravan, Sturgis trips to D.C. Vess of Ft. Jackson?

Advance knowledge of incidents at Hoover Funeral with others, Pablo Fernandez, when that happened, who was source of information, what point in time he first indicated Hunt, White House and CIA, Sturgis-McCard assistance at Hoover Funeral, when Baldwin had chance meeting with Hunt at Barker's office, Duration of acquaintance with Barker, how much of Barker's history does Chajet know?

Did Barker every say that Hunt was the Big Boss of this operation?

Did this meeting occur the week after the caravan?

Did Sturgis, in that same week, mention other White House persons? (McCard, Erlichman, Coleson and Mitchell) Do you recall any other White House names being mentioned?

Ask what Chajet knew about Sturgis' employment and finances.

Did Chajet know about Sturgis' daughter and mother and their medical problems?

Did he know that Sturgis' wife worked? Where, when and her salary?

Did Sturgis always seem to have money both before Watergate and when he was home on bond?

Did Chajet know where he got his money?

What did Sturgis say about Eric and Samayo raising money for his bond and defense?

Did Sturgis tell him that Artime raised money for him or gave him money?

When he was home on bond, does Chajet know of any contact between Sturgis and any of the other defendants? If so, what are the names?

What did Sturgis and/or Barker tell him about what a great guy Artime was?

How long had Sturgis known Anderson and how did they meet? Where, when, etc.

Did Anderson have any role in Sturgis regaining his citizenship?

What did Sturgis think of Anderson?

How of-ten did he speak of Anderson?

How often did Sturgis and Anderson talk to each other?

In regard CHIPP, did Sturgis say in July 1971 that Anderson owed him some favors?

Did Sturgis constantly speak of Anderson as a source of aid and funds for CHIPP? How long did this impression last?

In regard to Sturgis' "Big Project" does he feel that Sturgis discussed the Big Project with Anderson and, if so, how frequently and in what detail?

Does he remember that months before the Watergate that Anderson had promised Sturgis full press cooperation with the Project?

Did that puzzle Chajet and why?

Did he think those two things were incompatible?

Was he under the impression that Sturgis was in contact with Anderson right up to the second time Sturgis was in the Watergate?

When does Chajet recall Sturgis asking him to drive him to the Airport for what turned out to be the final Watergate trip?

What makes him think it was Saturday instead of Friday?

What impression did Chajet have in regard to Sturgis' feeling the day he took him to the Airport?

What did Sturgis say about having enough money to swing ~~EMEX~~ CHIPP and liberate Cuba?

Did Sturgis indicate that the Project (Watergate) had support from higher-ups and from Anderson?

Chajet indicated that he saw in a newspaper that Anderson and Sturgis accidentally met at the Washington Airport when Sturgis arrived for the second Watergate entry. Did he believe it was accidental? Could he have heard it from Sturgis at a later date rather than having read it in the newspaper?

Did Sturgis later tell him that Anderson had visited him in jail and had spoken up for him at his bail bond hearing?

Does he have any additional pertaining to these things?

Chajet indicated that both Sturgis and his wife were in contact with Anderson when Sturgis was home on bond. Did Sturgis tell Chajet ~~or~~ that ~~Anderson told him or his wife~~ after the Watergate that he would help out with money or that she could stay in Anderson's home when she was in Washington for any hearings, visits or trials?

What is Chajet's relationship with Jan Sturgis?

Did Sturgis indicate to Chajet that he wanted his life story written?

Did Chajet understand from Sturgis that Anderson would help in writing the story? Was this something they had talked about (Anderson and Sturgis) over a long period of time?

Was this constantly on Sturgis' mind?

What kind of a story was it going to be?

Did some ghostwriters from New York come down to see Sturgis when he was out on bond?

Did Anderson have anything to do with sending the writers?

~~What~~ What was Sturgis' reaction to these ghost writers?

~~When~~ do you remember Sturgis asking you to drive him to the Dupont Plaza

Why did Sturgis want to go there, how long was he there

what did he say they talked about and what did he say when he returned/

what did he have with him, what condition were they in and how many?

What did he do with them - Did he give any to Chajet? what did he do with them?

What was Sturgis attitude after WG? How often did you see him then?

What did Sturgis say about being caught?

Did Sturgis think being caught would make good material for his book?

Did he think anyone had deliberately caused them to be caught?

Did anyone tell him being caught would be good material for the book?

Did Sturgis ever talk about any sabotage of the operation

What did he say about the tape, and Mqoho using his notary seal?

What did Mqoho or Sturgis say about Gerstein, Did Anderson say he would testify for Sturgis or Mqoho and help either or both?

Do you remember a time when Anderson's name was mentioned in a conversation between Sturgis and Barker, when was that and what was said and why were you there?

Is it your impression that there developed a rift between Sturgis and Anderson? Did Sturgis say anything about that and what did he say?

When did this happen, before or after the Ghost writers?

Do you know what caused the rift, Did Sturgis say "I don't want to see that bastard no more"? Who brought up the conversation? What else was said? Did Sturgis mention the back falling through?

When was your last contact with Sturgis or his family? What was said? Phone - Person or what.

Did Jan say that Frank said he wanted this and that she should stand behind him? Did she ever discuss any of this with you?

Where did the young Democrats enter into the picture, who were they, Did Sturgis have any knowledge or association with them. Who was the man with the Greek name? Where was their headquarters, did you ever go there, when with whom, and what was discussed, how often?

What do you think of Sturgis' attitude about being a mercenary, would he sell information for money, do you think he would let his mercenary actions harm the cause or patriotism? Was his primary drive to liberate Cuba? Would he sell information for money to be used in his cause? Is Sturgis a person of fierce loyalty? Did Sturgis believe in the Anderson, and did he think he would ever double cross the country or cause? Do you think on this basis Sturgis continuously deceived the big project with Anderson?

Did Sturgis ever mention any other persons from south Florida who were involved or asked to be involved in the big Project?
